## **Provincial School Sport Structures Capacity Development**

#### INTRODUCTION AND BACKGROUND

The School Sport Programme is a Sport and Recreation South Africa and Department of Basic Education initiative that seeks to maximize participation in sport and recreation activities in schools across the Republic of South Africa. KZN DSR and DoE focuses on mass participation in sport amongst learners with special emphasis on previously disadvantaged urban and rural schools. The programme begins at school inter-house participation, moves to circuit, wards, districts, provincial and up to national level. KZN DoE coordinates and organize participation at lower levels and KZN DSR support and fund programmes /selection from a district up to national level championships.

The programme is provincially run through school sport code structures that are affiliates of the sport federations. The KZN Department of Sport and Recreation, School Sport Directorate has a mandate to support DoE through available resources to form, facilitate the formation and revival of schools sport code structures. These structures play a pivotal role to administer leagues and organize championships at all the levels. A formally existing structure is required to have an adopted constitution, meets annually at the AGM, elect its executive as per its constitution, keep its records and account monthly/ quarterly in respect of their programme of action that complements or support school sport programme for the entire year

#### CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- Section 4(1)(b)(iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging)<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
